#### NOTES

Prices EXCLUDES stripping of any existing vinyl films.

Price excludes artwork.

Print ready artwork is to be supplied by client.

Final dimension MUST be taken prior to print.

#### VEHCILE WRAPPING

Vehicles to be delivered clean, but not polished, to UNIT 5 PENRAL PARK 17 CORDOVA CLOSE BRIARDENE DURBAN by no later than 08h30 on the date of Brand date supplied.

#### PLEASE NOTE

Polar Printing Fleet Auto & Truck Branding will not be held responsible for any damages incurred by the branding process. No SILICONE based polishes. Vehicles booked for FULL WRAPPING will be required to stay overnight for post heating the next morning. Late arrivals, and vehicles arriving that require cleaning, will lead to a 1 day delay over and above the full working period required.

Polar Printing Fleet Auto & Truck Branding will not be held liable for any damage caused to vehicles, or painted surfaces, during the application of vinyl and/or removal of components or vinyl film under the following circumstances;

- If the vehicle is older than three years at the time of branding
- If the vehicle has been re-sprayed due to an accident prior to the branding
- If plasticized, colour coded, components are not OEM spray painted
- If paint is lifting on any part of the vehicle or on colour coded plastic areas i.e. plastic bumpers, side beadings etc

All vehicles marked, branded or wrapped may not leave the premises until paid for in full and payments have been verified.

**Terms and Conditions:**

Upon confirmation of the order a VAT Invoice will be raised requiring payment in part, a deposit of 70% or in full, all invoices below R5000.00 to be paid in full.

All signage to be paid in full (whichever is applicable) or vehicles wrapped on site, including notification of such, or supporting documentation. Production will commence only once payment notification has been received, the order has been confirmed in writing or on receipt of an official order number, including confirmation in writing of final artwork.

All non-account clients will be required to pay in full, prior to production, on amounts below R 10,000.00 excl vat. Amounts above shall require a minimum of 70% deposit, with the balance payable on completion of the order PRIOR to delivery, collection or installation.
